Rustin of SEH presented and contract for them to do the design work on the Lawrence Street Bridge. The council wanted the contract to state that it would be billed for an hourly rate not to exceed \$68,925. The design will be for a bridge.

A representative for the Floyd Mitchell Landfill said they were having a hard time making quorum at their meeting and asked that the City representative, Roger Brumm make an effort to make those meetings.

Allyn Brumm said that there are a lot of cars that being parked on Broad Street and made it hard for the snow to be removed. The council asked that A. Brumm contact the owners of the cars.

Taylor Flugge, President, of the Kids Care board was present to inform the council that the daycare is looking into installing a security system. They had talked to a company to get an idea on cost. Taylor was asked to get the company rep back to discuss further and Roger Hemann said he could be present. A. Brumm moved and Gerbig seconded to pay for a dishwasher the daycare needs. All voted aye.

The Mayor stated that a company wants to have a food pantry in the community. They will be at the April meeting to provide more information.

The splash pad continues to raise money and had a very successful Bingo.
