

# COUNCIL PROCEEDINGS

## CITY OF STACYVILLE

Mayor Paul Halbach called the regular April meeting of the Stacyville City Council to order at 7:30 p.m. on Monday, April 10, 2023, with council members Roger Brumm, Allyn Brumm, Jake Gerbig, Alex Emerson, and Roger Hemann present. The Mayor then welcomed all guests and called for approval of the meeting agenda. A. Brumm moved to accept the agenda seconded by Gerbig and carried. Gerbig moved and Emerson seconded to approve the minutes. All voted aye.

Mayor Halbach opened the public hearing for the 2023/2024 City of Stacyville Budget 7:31 p.m. The clerk summarized the Budget and told the council the changes the state made. Hemann moved and R. Brumm seconded to close the Public Hearing at 7:34 P.M. All voted aye. Hemann moved and Gerbig seconded by RESOLUTION 2023-3 TO APPROVE THE 2023/2024 CITY OF STACYVILLE CITY BUDGET. All voted aye.

Rich Brumm, County Engineer, informed the council that the County is applying for a grant to do county roads that go through the City. The grant will pay 70% to 80% of the cost. Concrete will replace the asphalt in town. It will likely cost the City about \$338,000. Rich wants to know if the City would like to go ahead. The Clerk will check on available funds. The project would be done in the 2024/2025 fiscal year.

Jessica Kettleison was present to inform the Council about having a small food pantry in Stacyville. There would be no income limitations on users. There would not be any cost to the City.

Summer Rec will be starting June 6. Like last year there will be t-shirts for the kids.

The council asked to change the wording of the contract with SEH for the Lawrence Street Bridge to say that the cost "will not exceed". The Mayor will sign the new contract.

Hemann moved and R. Brumm second by RESOLUTION 2023-04 TO ADOPT THE MITCHELL COUNTY MULTI-JURISDICTIONAL MULTI-HAZARD MITIGATION PLAN. All voted aye.

The Mayor will talk to the Sheriff Department to have them be present in the City to help with the speeding. There was no further discussion concerning the Kids Care security system.

The splash Pad committee has about \$130,000 and told the council they need to line up a contractor. Hemann moved and A. Brumm seconded to approve K&N Mini Mart beer license. All voted aye. Colton Bruggeman wants to buy City Right of Way. It will be on next month's agenda.
