Mel Gerbig reported on the splash pad project. The committee will be ordering the features for the project this month.

The council agreed that the old library would be the best place for the food pantry.

Allyn Brumm moved and Hemann seconded to pay Ritter & Ritter Sewer Service \$80,712.50 for Sanitary Sewer I/I Reduction Project. All voted aye.

Gerbig moved and A. Brumm seconded to install tile and fill 20 feet of ditch next to the historic sign on North Albion Street. All voted aye.

Joe Erbe reported to the council that fuses continue to blow at the sewer generator. Erbe is working on solutions to the problem.

Shannon Adams is going to get more activity at the Farmers Market. Ideas were food truck, inflatables, dairy trailer for starters. She obtained a donation to help with the expenses.

The county has asked the City if they would was to share in new roads through the City. The Cost to the City would be for side street intersections and have an estimated cost of \$338,000. The Clerk told the council that the payment for the project could be workable.

The City was offered to enter into a Marketing Agreement with the National and lowa League of Cities to offer the citizens the opportunity to buy warranty insurance for their exterior water and sewer lines and internal plumbing and drainage. The only part that the City will have is to have the City name be part of the promotion. There will be
