Again time was spent on discussing how to slow the traffic through town on Broad Street. The City was told that if the City wants a stop sign on Broad Street, it must be approved by the County Supervisors. Other comments were getting the north speed flashing light to work better, more and bigger speed limit signs and sign saying something to the effect "Slow Down for our Children".

The cement pad for the splash pad has been installed. Still need to install electrical, plumbing and diverter valve.

The Clerk informed the council that Jendro is raising the rates as provided for in the contract and also passing on an increase in the landfill dumping fees.
